Installation of the Livernois Throttle Enhancer

2008-17 Ford

Read all instructions and fully understand them before installing your Livernois Motorsports Throttle Enhancer module. Disconnect the battery terminals and remove keys from ignition before installation.

Place De-Electric Grease onto every electrical connection.

- 1. Installing the Livernois Throttle Enhancer is very simple. First thing you will need to do is locate the connector on the top of your fuel pedal inside the vehicle.
- 2. Disconnect the factory harness and connect the supplied Throttle Enhancer harness to both the throttle pedal and the factory harness. This allows us to interrupt the signal without cutting the wire harness.
- 3. Once the harness is connected you will need to connect the supplied switch to the Throttle Enhancer harness. This will plug into the 6" pigtail that comes off the white connector that will to the Throttle Enhancer module.
- 4. Locate a spot to mount the switch so that you can adjust it if needed. Now route the switch to this location. To mount the switch, remove the knob by loosening the allen screw on the side of the knob and slide it off. Then remove the nut from the shaft of the switch. Drill a hole just big enough for the shaft of the switch to slide through. Now thread the nut back on and tighten it back. Slide the knob back on the stem of the switch and tighten the allen screw.
- 5. Now you will need to locate a spot to mount the module out of the way. I recommend using the zip ties to hide it under the dash.
- 6. Next tie all the wires up and out of the way so that they don't get tangled in the pedal or wrapped around your foot.
- 7. The switch can be adjusted while driving the vehicle to control output of the Throttle Enhancer module. With the knob turned all the way counterclockwise the pedal will perform as it did stock. To make the pedal more responsive, turn it clockwise. This can be done at any time while driving or sitting still.
